This cookie policy was last updated on 25/09/2024 and applies to citizens and legal permanent residents of the European Economic Area and Switzerland.

1. Introduction

Our website, www.alpevision.com and www.alpevision.shop (hereinafter: "the website") uses cookies and other Related technologies (for your convenience all technologies are referred to as "cookies"). Cookies are also placed by third parties that we have engaged and who collaborate and/or oTo complementary and/or ancillary services to this site. 2. What are cookies?

Cookies are simple files sent together with the pages of this site and saved by your browser on your computer's hard drive or other devices. The information collected in them may be sent back to our servers or to third-party servers and/or ours on other sites website during this and/or during the next visit.

3. What are scripts?

A script is a piece of code used to make the our website. This code runs on our servers or on your device.

4. What is a web beacon?

5.1 Technical or functional cookies

5.3 Marketing/tracking cookies

Marketing/tracking cookies are cookies or any other form of storage used to create user profiles to display advertising or to track you on this website or on various websites of ours and not for similar marketing purposes.

5.4 Social media
